Eligibility

Recipients are selected on the basis of eligibility and the applicant must be enrolled fulltime in an undergraduate university program in Canada. The grant is available to Canadian students.

Qualifications

Applicants will be judged on academic achievement, practical experience and a commitment to a career in projects and operations in the mining industry.

Application Requirements

Complete application packages must be submitted by October 30th and include:

- The application form
- Letter of referral from a professor
- Essay describing any experiences you have had with health and safety in the mining industry and how you are preparing yourself for a career in mining and processing (max. 400 words)
- Resume (curriculum vitae)
- A copy of your current academic transcript (can be unofficial)
- A confirmation of enrollment to your program.

This grant was established by Laverne Popowich and is administered by the CIM Foundation:

- The application form
- Letter of referral from a professor
- Essay describing how you are preparing yourself for a career in the mining industry, including practical experience (maximum 400 words)
- Resume (curriculum vitae)
- A copy of your current academic transcript (can be unofficial)
- A confirmation of enrollment to your program

All of this information will be considered by the CIMF Scholarship Committee when they make their selection. While academic achievement is important, submissions should demonstrate a keen interest in any facet of the mining industry, as well as describe the candidate's problem-solving skills, ability to work in a challenging environment, as well as experience working within organized teams, all in the context of both a university and work setting.

Two grants are to be awarded annually. All qualifying scholarship applicants will receive a complimentary CIM student membership.
